4. First-Aid Measures

Description of first aid measures

Remove contaminated clothing.

If inhaled: Keep patient calm, remove to fresh air, seek medical attention.

On skin contact: Wash thoroughly with soap and water.

On contact with eyes: Wash affected eyes for at least 15 minutes under running water with eyelids held open.

On ingestion:

Immediately rinse mouth and then drink 200-300 ml of water, seek medical attention.

Most important symptoms and effects, both acute and delayed

Symptoms: The most important known symptoms and effects are described in the labelling (see section 2) and/or in section 11. Further important symptoms and effects are so far not known.

Indication of any immediate medical attention and special treatment needed

Treatment: Treat according to symptoms (decontamination, vital functions). No known specific antidote.

5. Fire-Fighting Measures

Extinguishing media

Suitable extinguishing media: Water spray, carbon dioxide, foam, dry powder

Special hazards arising from the substance or mixture

Carbon monoxide, hydrogen chloride, hydrogen fluoride, carbon dioxide, nitrogen oxides, sulphur oxides, organochloric compounds.

Advice for fire-fighters

Special protective equipment: Wear self-contained breathing apparatus and chemical-protective clothing.

Further information:

In case of fire and/or explosion do not breathe fumes. Keep containers cool by spraying with water if exposed to fire. 6. Accidental Release Measures

Personal precautions, protective equipment and emergency procedures

Methods and material for containment and cleaning up

7. Handling and Storage

Precautions for safe handling

No special measures necessary if stored and handled correctly. Ensure thorough ventilation of stores and work areas. When using do not eat, drink or smoke. Hands and/or face should be washed before breaks and at the end of the shift.

Virtually nontoxic after a single skin contact. Virtually nontoxic by inhalation. Of moderate toxicity after single ingestion. The product has not been tested. The statement has been derived from substances/products of a similar structure or composition.

Experimental/calculated data: LD50 rat (oral): 300 - 2,000 mg/kg LC50 rat (by inhalation): > 1.7 mg/l 4 h Highest concentration available for testing. No mortality was observed. Germ cell mutagenicity

The product has not been tested. The statement has been derived from the properties of the individual components. Mutagenicity tests revealed no genotoxic potential.

Assessment of carcinogenicity:

In long-term studies in rats the substance induced thyroid tumours. The effect is caused by an animal specific mechanism that has no human counterpart. In long-term studies in mice in which the substance was given by feed, a carcinogenic effect was not observed.

Reproductive toxicity

Assessment of reproduction toxicity:

The product has not been tested. The statement has been derived from the properties of the individual components. The results of animal studies gave no indication of a fertility impairing effect.

Developmental toxicity

Assessment of teratogenicity:

The product has not been tested. The statement has been derived from the properties of the individual components. Animal studies gave no indication of a developmental toxic effect at doses that were not toxic to the parental animals.

Repeated dose toxicity and Specific target organ toxicity (repeated exposure)
